In order for Chase to have violated section 45-9-402(1), MCA, it is necessary that the judgment of the District Court of the First Judicial District was rendered by a court of record in the State of Montana. It was not so rendered. The judgment was entered on February 6, 1975, by the clerk of the district court for the County of Lewis and Clark. Section 1-3-102, MCA, provides that "The term `court of record' when used in this code means... the district court or judge of the district court...." The district court of the First Judicial District of the State of Montana was thus a court of record. Section 2-4-101(1)(a), MCA, provides that "[a]ll other judgments and decrees may be rendered and entered by the district court or judge in any civil action or proceeding." Section 1-3-102, MCA, does not define the term "judgment." Section 1-1-204, MCA, defines the term as "the final determination of the rights of the parties in the action." (Emphasis supplied.) We have concluded that the term "judgment" as used in section 45-9-402(1), MCA, means "the final determination of the rights of the parties in the action." To hold that a judgment was rendered by the district court of the First Judicial District on the day that the judgment was signed would mean that a judgment was final for purposes of appeal even though the appeal bond had not yet been filed, and the attorney for Chase did not have notice of the judgment. Such a result is contrary to both logic and common sense. In Tri-River Levee Dist. v. Holman (1953), 127 Mont. 151, 155, 258 P.2d 679, 682, this Court stated that the filing of the appeal bond is a condition precedent to the exercise of the right to appeal. We stated that in order for the district court to be divested of jurisdiction to hear and determine the appeal, the appeal bond must be filed.
